

**Platteville Monthly School Board Meeting-Minutes**  
**Monday, October 30, 2017 – 7:40 p.m.**

President Miesen called the school board meeting to order on Monday, October 30, 2017 at 7:40 p.m. at the OE Gray Professional Learning Center-IMC.

Steve Obershaw made a motion to pass a resolution to certify a school district property tax levy of \$8,837,171 for the 2017-18 school year. This includes Fund 30 Debt Service in the amount of \$1,230,213 and Fund 10 General Fund in the amount of \$7,606,958. This supports a school district operating budget of \$17,147,807. Nancy Bongers seconded the motion. Motion carried. 9-0 vote.

Vikki Peterson made a motion to amend the 2017-18 budget as presented. Abulkhair Masoom seconded the motion. Motion carried. 9-0 vote.

Curt Timlin made a motion to approve participation at UW-Platteville and SWTC in the Youth Options program during the spring of 2018 as presented. Vikki Peterson seconded the motion. Motion carried. 9-0 vote.
